WARRANTY COVERAGE

Centrodyne's warranty obligations are limited to the terms set forth below: Centrodyne Inc. ("Centrodyne") warrants this taximeter product against defects in materials and workmanship for a period of ONE (1) YEAR from the date of original purchase from an authorized dealer. If a defect exists, at its option Centrodyne will (1) repair the product at no charge, using new or refurbished replacement parts, or (2) exchange the product with a product that is new or which has been manufactured from new or serviceable used parts and is at least functionally equivalent to the original product., or (3) refund the purchase price of the product. A replacement product/part assumes the remaining warranty of the original product or NINETY (90) days from the date of replacement or repair, whichever provides longer coverage for you. **BATTERIES, RELAYS AND PRINT MECHANISMS ARE NOT COVERED UNDER WARRANTY SINCE CENTRODYNE RECEIVES NO WARRANTY FROM ITS' SUPPLIERS ON THESE ITEMS.** However, if a defect is found in any of the above parts within the first thirty (30) days after purchase Centrodyne will replace the defective part.

OBTAINING WARRANTY SERVICE

If you purchased the product in the Canada deliver the product, at your expense, to the Centrodyne Authorized Service Provider from whom you purchased it.
